Good morning. I hope this day is going well for everyone.

I have a serious matter that needs to be addressed with DDEAMC. I went to the patient advocacy office on January 10, 2014 with a complaint about some disturbing information I found in my medical records. I found many slanderous writings in there by various doctors.

Not only were my records included in a huge box, but there was also another gentleman's paperwork with his name, address, phone number, and social security number. Not to mention, the many procedures he had done at DDEAMC, which to my understanding, is a HIPPA violation.

I have written copies of my complaint, as well as full copies of all of my records. I expressed that I wanted a follow up to the inquiry that was SUPPOSED to take place. However, I have not heard a word since.

What can we do to rectify this situation? I would love some answers, as I have been going through problem after problem with the doctors at this facility. Thank you. *(1 Like)*

Rachel Flanagan I work in the medical field, it is a huge HIPPA violation!!!! *(2 Likes)*

Eisenhower Army Medical Center Please call the public affairs office at 787-5301 after the town hall is complete and I will put you in touch with someone who can address the issue. *(1 Like)*

Laura Hardy Aldrich Thank you.

Adam Maynard related to what rachel said, I used to think the military was exempt from HIPPA.

Laura Hardy Aldrich I would hope not. I don't want anyone getting ahold of our social security numbers and using them for fraudulent reasons. I would be livid. If that IS the case, there needs to be some sort of warning for patients stating that their information could be given to anyone at any point in time. *(1 Like)*

Eisenhower Army Medical Center The military is not exempt from HIPAA and we comply with Joint Commission standards, as do civilian hospitals. *(6 Likes)*

Angela Duckwiler previously submitted a question.

ISSUE: I am interested in finding out what the leadership is doing to resolve the frequency of the elementary school bus being late?

There is an automated system set to call parents. I get a call letting me know the bus is late around 1600 each time it happens. School gets out at 1505 I believe and the bus when on schedule drops the kids off at 1525. So this is another issue that I believe needs to be addressed. As well as the details provided in that message since it goes out to all bus riders and is not based upon bus numbers.

I have tried reporting this problem through other channels and it just seems like everyone likes to point fingers and make excuses. Neither of which resolves the problem. The best POC I have found is the school liaison. *(2 Likes)*

Fort Gordon Response from DFMWR: We've coordinated with school officials and the superintendent's office in this matter (Richmond County Board of Education). The current policy is that notification must come from the school district's transportation office. We're inquiring whether the school can notify the parents directly (like Columbia County Board of Education) does, as opposed to the transportation office. We are waiting to hear back from the Superintendent's office and will share this information as soon as we receive it.

Mindy Hillway My daughter was riding the bus but I pulled her off because I was so late by the time she got home some night not until 430 she is now a car rider

Col Samuel Anderson MS Duckwiler, with two children in Freedom Park I have personally experienced the same frustrations. I have personally raised the issue to the Freedom Park Principle and the Deputy Superintendent of Richmond County Schools. We will continue to work this issue. *(3 Likes)*

Amanda Clarke Yeah one day my daughter got home at 4:10 and the late bus call came at 4:15....not really much help at that point. I will say the past couple calls I have gotten have given the bus number though.

Adam Maynard

Are there any plans to expand parking (i.e. parking garage) at the Eisenhower Army Medical Center on post? This morning I literally witnessed two vehicles "competing" over a parking spot that someone was leaving, on more than one occasion. Thanks (4 Likes)

Eisenhower Army Medical Center There are currently no plans to expand the parking at Eisenhower. We are looking at possibly expanding clinic hours and there is additional parking available in all the parking lots including the WTB and Tingay parking lots located on East Hospital Road. (1 Like)

Kara Kennedy Has anyone looked at expanding the disabled parking spots? The staff seem to occupy all the disabled parking spots leaving a lot of patients, including cardiac patients, walking up that huge hill to the entrance. It is too bad we can't have a little shuttle bus that would pick people up. There are a lot of retirees that use the hospital. (2 Likes)

Eisenhower Army Medical Center Ms. Kennedy, There has been discussion of ways to expand the number of handicap spots. We do have golf carts that help patients but due to regulations it is difficult to get volunteers. We currently have two volunteers who man the carts to shuttle patients from the back of the parking lot. (1 Like)

Jennifer Freeman What are the guidelines for staff parking? It was my understanding that there is a staff lot. However, even early in the morning, the closest spots are occupied by staff. On more than one occasion I've been at DDEAMC at 0630 (to get coffee) and have observed staff members (wearing scrubs/badges) walking out to their cars. Shouldn't the closest spots be reserved for patients? Obviously I'm not a patient in the situation I've described, but I would think that patients have priority for the closest spots considering they are "customers".

Christina Whiting What are the regulations to volunteer?

Kara Kennedy We may just need to get the word out better to potential volunteers since I know a lot of facilities on post have so many volunteers they've been turning individuals away. I've been here for almost two years and I wasn't even aware DDEAMC had volunteers or needed volunteers for shuttle service.

Eisenhower Army Medical Center Ms. Freeman: The Staff is required to park in the Staff Parking on the Flagpole side of the building. Our Security is stationed each morning and throughout the day in the patient lot preventing Staff or badged employees from parking in the patient lot. (1 Like)

Eisenhower Army Medical Center Ms. Whiting: Please see the Red Cross in EAMC on the 3rd floor and they can start the process to getting you registered to be a volunteer in any part of the hospital. (1 Like)

Adam Maynard Thank you for responding to my question. I forgot to mention the other reason why it appears that parking is an issue. There are multiple vehicles that were parked on the grass parking lot medians, and compact cars parking in the motorcycle spots (next to tree median). I know it's an easy target for a ticket, but I suppose they take the risk for a shorter walk.

Eisenhower Army Medical Center The Leadership has started to encourage ticketing by the Post MPs for illegal parking in the parking lots. Staff is encouraged to use the Tingay and WTB and those parking on the grass or the curb run the risk of being ticketed or having a boot placed on their vehicle. *(1 Like)*

Jennifer Freeman Parking is definitely an issue at the hospital. I understand that the post has gone through some serious growth and that it will continue, but it is unreasonable to expect patients to walk from the parking lot near Tingay. I understand that security does their best to keep staff members from parking in the patient lot, but even if they are 100% successful, the reality is that there just aren't enough spots available.

Fort Gordon

Frederick Kmiecik previously submitted a question.

ISSUE: There is a parking issue at Gym 6 during the work week (Monday - Friday), which needs to be addressed. A posted sign designating the parking lot in front of Gym 6 for the shopette and Gym 6 patrons, seems to be disregarded by soldiers and civilians that work nearby.

This affects all patrons who use the Gym and forces them to park a distance away either on Barnes Ave parking lot or on "B" St parking lot. Many disable retirees use the equipment and facilities offered at Gym 6, since it not tailored to the power lifters or body builder crowds.

Recommend that Gym staff have the authority to issue parking tickets to unauthorized vehicles or allow Gym patrons to park on 21st St. Maybe MP can start enforcing the posted sign and do spot checks *(2 Likes)*

Fort Gordon Response from DES: Thank you for bringing this issue to our attention. The Law Enforcement Center Traffic Section will assess the situation and make sure that there is a do-able parking plan that is fair for all patrons. Please be advised, though, that the limited parking in this area is open parking on a first-come, first-served basis.

Melissa Olson

I have a question regarding housing. We fulfilled our lease and moved off post a few weeks ago. While signing our paperwork in February, we were told that our allotment for housing had been stopped and that our BAH would appear on the March 15th check. When my husband cleared on March 7th, he had to pay almost 300 dollars for days 1-7. And they still took our BAH. I'm just curious if we will get refunded the bah they took? I hope this makes sense. Thank you. *(3 Likes)*

Samantha Morehead Yes but it can take up to 6 months *(1 Likes)*

Laura Hardy Aldrich They're quick to take it, slow to give it back. That's the general rule that I've learned. *(5 Likes)*

Melissa Olson So should it appear normally though on the EOM check? I wish the lady would have told us the correct information at Balfour. *(1 Like)*

Samantha Daher Thank you for your question. Your complete BAH refund should be included in the 1 April 2014 LES. If there are any problems please contact me at that time. Samantha Daher, assistant community manager.

John Curry

The garrison command team would like to thank everyone for their part in the post-storm clean. We still have some work to do, but the job done by the installation staff, service members, and their units, housing residents and all our other partners has been outstanding. Thanks for everything! *(6 Likes)*

Laura Hardy Aldrich It's been a slow recovery, but they are doing the best they can in the amount of time they have. (1 Like)

Tiffany O'Schnookenbocker Post looks better than the surrounding towns! I get proud every time I drive around Fort Gordon... (2 Likes)

Lacey Lewis

I also have a question about housing. Why is it an E6 paying \$1350 in BAH to Balfour Beatty gets stuck in a house with the roof literally caving in on them, work orders barely taken care of, appliances not working when moving in...and people paying a cleaning "fee" in the area of \$300 when clearing the house, yet when a new family moves in the house is in disgusting conditions? I don't think any family should have to deal with that, no matter the rank. Are there going to be ANY changes made to the ponzi scheme balfour beatty is running? (6 Likes)

Samantha Daher Balfour Beatty Assistant Community Manager, Samantha Daher, responds: Mrs. Lewis thank you for your feedback. Balfour Beatty's goal is to provide the best housing possible. The rent amount is fixed for all soldiers based upon rank and that is an Army-wide policy for privatized housing. In regards to the conditions in your home we will have our maintenance supervisor, Nan Rocker, contact you to take care of any issues that you have.

Lacey Lewis Same generic answer, but no solution. Thanks for your reply anyway. (3 Likes)

Adam Maynard ya housing increments are weird here. I remember at Fort Campbell there were neighborhoods for E-1 to E-4, ones for E-5 to E-6, and then I think E-7 and above are lumped together in there own neighborhoods too. It's strange to have such disparity for E-1 to E-6 BAH and they all live in the same quality housing. (2 Likes)

Lacey Lewis It's very weird here. I think an E6 who has spent 10 years in their job deserves a better quality house than what they offer. We don't live on post anymore, but I hate seeing other families get treated this way. We moved off because of the issues. BAH is much better spent off post (3 Likes)

Samantha Ramirez I agree with Lacey, E-6 with 10 years in should be offered better housing with quality communities. (3 Likes)

Lacey Lewis Not to mention, we KNOW Balfour Beatty isn't broke! Why can't they at the very least do some real renovations with these houses, or better yet...build new houses. New Olive isn't very convenient for those who only have 2 kids. They only allow you to move in if you have 3PLUS kids. What about the families who only have 2 kids, yet still should be held at a higher preference for good quality housing? I'm not saying an E1 or E2 deserves these houses by any means, because it doesn't make it any better for an E6 who has been in quite a bit of time in their job. Why should a 2nd LT who has had maybe a year or two in have a really nice house, but an E6 who has had a lot of time in get a crappy house? Doesn't add up. And no, I'm not knocking officers down, but enlisted personnel should be treated better. (3 Likes)

Lacey Lewis AND..one more thing. \$1350 for a 75 year old house is a little overboard. Especially if you are in a "renovated" house where you pay utilities (maybe) Which generally people are getting stuck with paying overages when a house next to them is empty since they average it even on empty houses. The whole thing needs looked at. It's all a mess up there. (1 Like)

Brittany Perlow The fact is everyone regardless of rank should have a decent house to live in. As it stands this is not the case. No one deserves to live in a house that is literally falling apart around them. The system here is flawed and needs to be addressed. (3 Likes)

Samantha Ramirez My exact thoughts. Our Family of three decided to go off post for housing and is now living in a beautiful 4br 2 and half bath two story on main street in groves town for

1100 a month because fort gordon offered a sub par 4 bedroom for our entire bah. I have to say, we felt as though we had been slapped in the face by Balfour Beatty. Especially after finding out that there were other houses available in different communities on post. (3 Likes)

Samantha Ramirez We honestly just wanted a Nice two bedroom (1 Like)

Lacey Lewis I'm not implying any rank should have a better standard. Maybe I should have worded it different, sorry! But I did say that a 2nd Lt with a year or two in shouldn't have a better house than anyone, especially someone who has been in for 8 or 10 or more years. The conditions of these houses aren't acceptable. They're so old they smell to high heaven!

Tiffany O'Schnookenbocker It's your family's BAH--use it to your liking. If the post housing is subpar, don't live in it. If enough people follow, they'll have no choice. Either repair, rebuild, or tear down... (3 Likes)

Adam Maynard I do agree the higher quality housing you're entitled to should be bases on Rank and experience, not just rank or how many kids you have. I've seen this at other bases though, lower enlisted with 4 or 5 kids getting better housing than an E-5/6 with 2 kids

Lacey Lewis I get that...but what about the people who feel they can't afford to live off post? They shouldn't suffer either. We moved off post because our BAH wasn't going towards anything useful on post. But I agree...they need to do some major repair, rebuild, or replace.

Melissa Olson We are a family of 4 and my husband was an E-3 while we were living on post. We lived in a unrenovated unit while an AIT student lived across from us in a renovated. No kids. Just him and his wife. I understand everybody deserves a decent place, but it's not fair that someone who was there for 6-8 months was living in something that big with no kids. We moved off post and now live in a beautiful home under BAH. Now if we would just get the BAH we would be good. (1 Like)

Lacey Lewis There were some people in Gordon Terrace getting a reduced BAH rate payment on their house...so how is that fair?!?

Tiffany O'Schnookenbocker ACS offers great financial counselling. (1 Like)

Samantha Ramirez I think my issue here isn't necessarily the houseing as much as it is the zoning, I could not get a three or two bedroom home in any other area besides Gordon terrace. They zoned our family to Gordon Terrace even though they have olive terrace, mcnaair, lakeview, and maglin. They were willing to give my family of three a four bedroom but only in the Gordon terrace community. (1 Like)

Brittany Perlow It is not just zoning though it is overall quality as well. I currently live in an unrenovated home. I have had my house flood, I have had to had nearly every window replaced, I have had leaking ceilings, I have had roofs fall and sag etc. These are just the issues they were willing to address. (2 Likes)

Lacey Lewis Write to the Georgia Congressmen. They will start a Congressional investigation I would love to see where the money is really going. (2 Likes)

Lacey Lewis

I have a complaint and a question. Yesterday, there was an incident at the hospital in the family practice clinic. A nurse was overheard by a few individuals complaining about a ticket she received by an MP, and she later said in the conversation, and I quote, "He better hope he doesn't bring his kid in here to get shots because I may forget how to do my job and something bad might happen." I know I'm not alone here when I say that the staff at the hospital is beyond UNprofessional. How can we trust these people with caring for our children and ourselves? I refuse to be seen at Eisenhower because of how we have

been treated in the past, yet I can't be seen off post without switching to standard. How can we be assured that we can get better care, and why has this issue been unresolved for so long? There are EFMP families here who are getting awful care, and it's not fair to them or their children. Yes, we are very fortunate and thankful for the free healthcare we get, but we shouldn't suffer with unprofessional staff because of it. (6 Likes)

Hollis Bush Ma'am, The DES is aware of this issue and is working with the DDEAMC professional Standards folks to address the issue of the comments. Many people do not like being stopped by the Police and just vent out loud. However, we take all threats seriously and investigate it thoroughly (4 Likes)

Eisenhower Army Medical Center Ms. Lewis, Did you alert clinic leadership or register an ICE comment? We would like to address any issues with the personnel if you could provide specific information. Please contact the Public Affairs Office at 787-5301 after the town hall is completed. (3 Likes)

Lacey Lewis With all due respect Hollis Bush, there is a time and place for "venting out loud" and doing so in a professional setting where families can overhear threats being made is NOT that place. (7 Likes)

Lacey Lewis And it just proves that Eisenhower is not suitable to take our families to.

Lacey Lewis Yes, I did alert the leadership and I put in a complaint. (2 Likes)

Fort Gordon Directorate of Emergency Services Ma'am, the DES does agree with you about venting and we are actively investigating this incident. (3 Likes)

Lacey Lewis I really hope that Hollis Bush is not responsible for this investigation. I just can't understand why this is being taken so lightly as someone "not liking being stopped by the police." Well maybe if the employee had followed the traffic laws, they wouldn't have been stopped. These are families/kids lives being threatened. (3 Likes)

Fort Gordon Directorate of Emergency Services Ma'am, My apologies if it inferred that LTC Bush, the Director of Emergency Services, was doing the investigation. I am sitting in for him today. The Military Police Investigations section is conducting the investigation to identify the individual and coordinating with Eisenhower to take action. LTC Bush does take the comments seriously as do all of us on here. (3 Likes)

Adam Maynard Is this a new reg? I've just got here a month ago, ever other dfac I've been to has allowed anyone with a military ID to just pay and eat, If not on meal card. the iffy part has always been contractors (1 Like)

Tiffany O'Schnookenbocker The last time we tried to go, we were turned away and pointed to a sign that told us we were no longer allowed to eat--unless it was a holiday.

Tiffany O'Schnookenbocker Those holidays being Thanksgiving and Christmas.

Brooke M. Gillard that sucks (1 Like)

Adam Maynard I tend to think it's just a fort gordon thing then...

Tiffany O'Schnookenbocker It probably is--brought to my attention this Town Hall that it is at Commander's discretion. Rather frustrating... (2 Likes)

Is there some sort of procedure in place about calling people back to schedule an appointment for repairs?

Samantha Daher Thank you for your comment. Craig Chambers, Facility Manager, replies: our work order system includes the procedure to call residents back who leave a message. Depending on the time and type of work order, you can expect a call back within 48 hours for a routine work order, 4 hours for an urgent work order, or less than 1 hour for an emergency work order. If you have any particular unresolved concerns, please feel free to contact our facilities maintenance supervisor, Nan Rocker, at 706-772-5079. Again thank you.

Amanda Clarke Okay but this doesn't happen and the procedures aren't being followed then. It wasn't an emergency just a routine work order and they just show up. Amanda Clarke Ugh I would love to live off post but it's so hard to find a place big enough that takes cats. People will take dogs that can create so much more damage but not cats!!! So frustrating! (1 Like)

Based on the amount of incoming people (NSA/Cyber etc) and the upcoming destruction/re-construction of Robinson Ave. Are there any plans to provide another gate or expand entrances to Fort Gordon in the near future? Thank you! (10 Likes)

Col Samuel Anderson We recognize that our gates are heavily used, and the growth will exacerbate this problem. We are actively conducting planning in the hopes that we can secure funds to construct a new access control point. It will, however, be a lengthy process and we will make do with our existing infrastructure until then. Great question. (2 Likes)

Fort Gordon Directorate of Emergency Services Sir, The present system is mandated by Department of the Army. I will talk with our guards about getting upset. I know from being out there with them that some are standing by the kiosk and assisting patrons. As upgrades are fielded hopefully this will help. Thanks for the question

Col Samuel Anderson we understand your frustrations and the system is certainly not perfect. AIE does provide a more secure installation and we will continue to work through some of the challenges and ensure everyone is treated with respect as they access the installation. Thank You.

Gerald Lee King A common bad design is still bad design. It seems this one was built with tall healthy soldiers in mind. *(2 Likes)*

Laura Hardy Aldrich I also have a question about it being a more secure instillation when it only takes one registered ID to enter post. Anyone could come on post with a "friend". While they are supposed to be held liable for anything guests do, they could easily deny knowledge of people doing anything illegal. *(6 Likes)*

Fort Gordon Directorate of Emergency Services This system, checks our database of persons who are barred from the installation or who have had their post driving privileges suspended or revoked, usually drunk drivers. Folks who are asking for passes are run through databases to ensure their license and vehicles are current. We routinely catch persons who have expired or suspended licenses at the gates. The future upgrades will involve even more databases that will check folks. Even without the system, "friends" are still allowed on as long as the sponser vouches for them. *(1 Like)*

Ashley Marilyn Smith I'm not short but I still have to unbuckle to slide my ID. The system is not time efficient. It makes getting on post take even longer. *(2 Likes)*

Lori Gilliam Burchett The system used at Fort Hood was more accessible (from my 5'2" perspective). It used RFID and a quick touch of your ID to the scanner box instead of having to swip the ID through the scanner. Unless there's been a change of heart, it won't happen. We offered to volunteer and pay for the upkeep, and we were still denied. (This is coming from a non dog owner.) *(1 Like)*

Col Samuel Anderson we recognize there has been a lot of interest in building a dog park on the installation. We have looked at this from a lot of different angles, in terms of how it would be supported, and at this time we have determined that a dog park on the Installation itself is not feasible. We will continue to explore options. *(1 Like)*
