The verdicts published in this Teal Hash focus on, but is not limited to, the Second Judicial Circuit (Southeast) and include Eglin AFB, Fort Benning, Fort Bragg, Fort Gordon, Fort Rucker, and Fort Stewart.

Crime Victims Rights

The right to be reasonably protected from the accused.

The right to reasonable, accurate, and timely notice.

The right not to be excluded from any public proceedings.

The right to be reasonably heard.

The reasonable right to confer with government's attorney.

The right to full and timely restitution as provided in law.

The right to proceedings free from unreasonable delay.

The right to be treated with fairness with respect for the victim's dignity and privacy.

Sexual Assault Related Courts-Martial Results of Trial

Fort Bragg, Jan. 31

Name: SPC Andrewio B. Fennell

Conviction: By a military judge, pursuant to his pleas, of one specification of rape of a child, two specifications of sexual assault of a child, and one specification of sexual abuse of a child in violation of Article 120b, UCMJ.

Sentence: Reduced to the grade of E-1, forfeit all pay and allowances, confined for 45 years, dishonorable discharge.

Fort Bliss, Jan. 5

Name: PFC Isaac P. Buckland

Conviction: By a military judge, pursuant to his plea, of one specification of attempted enticement of a minor in violation of Article 134, UCMJ.

Sentence: Reduced to the grade of E-1, confined for 3 months, bad-conduct discharge.

Fort Carson, Jan. 12

Name: SSG Donald A. Gibson II

Conviction: By a military judge, pursuant to his pleas, of one specification of attempting to make an indecent visual recording, one specification of false official statement, and one specification of making an indecent visual recording in violation of Articles 80, 107, and 120, UCMJ.

Sentence: Reduced to the grade of E-4, confined for 164 days.

Fort Campbell, Jan. 13

Name: SGT Norman L. Clark

Conviction: By a military panel, contrary to his plea, of one specification of false official statement, one specification of rape of a child, and one specification of sexual abuse of a child in violation of Articles 107 and 120b, UCMJ.

Sentence: Reduced to the grade of E-1, forfeit all pay and allowances, confined for 12 years, dishonorable discharge.

Joint Base Lewis-McChord, Jan. 17

Name: SSG Fransisco C. Lara

Conviction: By a military panel, contrary to his plea, of one specification of sexual assault in violation of Article 120, UCMJ.

Sentence: Reduced to the grade of E-1, perform hardlabor without confinement for 30 days, dishonorable discharge.

Fort Drum, Jan. 26

Name: SPC Robert A. Lewin II

Conviction: By a military judge, contrary to his plea, of four specifications of sexual abuse of a child in violation of Article 120b, UCMJ.

Sentence: Reduced to the grade of E-1, confined for 36 months, bad-conduct discharge.

Sexual Assault Related Courts-Martial Results of Trial

Fort Bragg, NC Feb. 15

Name: PFC Ryan E. Mannan

Conviction: By a military judge, contrary to his pleas, of four specifications of sexual assault in violation of Article 120, UCMJ.

Sentence: Reduced to the grade of E-1, forfeit all pay and allowances, confined for 13 months, dishonorable discharge.

Fort Gordon, GA Feb. 15

Name: PVT Nicholas A. Yancey

Conviction: By a military panel of officer members, contrary to his plea, of one specification of possessing child pornography in violation of Article 134, UCMJ

Sentence: Forfeit all pay and allowances, confined for six months, bad-conduct discharge.

Fort Bragg, NC Feb. 16

Name: SFC Corry P. Brooks

Conviction: By a military judge, contrary to his pleas, of four specifications of rape and one specification of assault consummated by a battery in violation of Articles 120 and 128, UCMJ.

Sentence: Reduced to the grade of E-1, confined for 14 years, dishonorable discharge.

Fort Bragg, NC Feb. 21

Name: PFC Abelardo Gonzalez

Conviction: By a military judge, pursuant to his pleas, of three specifications of abusive sexual contact in violation of Article 120, UCMJ.

Sentence: Reduced to the grade of E-1, forfeit all pay and allowances, confined for 6 months, bad-conduct discharge.

Fort Bragg, NC Feb. 22

Name: LTC Gregory S. Pieper

Conviction: By a military judge, pursuant to his pleas, of one specification of disobeying a lawful regulation, seven specifications of sexual abuse of a child, one specification of conduct unbecoming an officer, and three specifications of possessing child pornography in violation of Articles 92, 120b, 133, and 134, UCMJ.

Sentence: Confined for 42 months, dismissed from service.

Fort Polk, LA Feb. 24

Name: CPT Isaac T. Dudley

Conviction: By a military judge, pursuant to his pleas, of one specification of cruelty and maltreatment and two specifications of wrongfully photographing the private area of another without consent in violation of Articles 93 and 120c, UCMJ.

Sentence: Confined for eight months, dismissed from the service.

Sexual Assault Related Courts-Martial Results of Trial

Norfolk, VA Mar. 24

Name: SOC Stephen Varanko, III

Conviction: By a military judge of one specification each of sexual harassment and assault consummated by battery.

Sentence: Reduced to the grade of E-6, confined for 89 days.

Jacksonville, FL Mar. 7

Name: NCC Edward W. Carullo

Conviction: By a military judge, pursuant to his pleas, of two specifications of attempting to commit lewd acts upon a minor, and one specification of wrongfully posting, via electronic communications, pictures of his penis while wearing a Navy uniform.

Sentence: Reduced to the grade of E-1, confined for 33 months, bad-conduct discharge.

Washington, D.C. Mar. 7

Name: CS2 Tawana Hymes

Conviction: By a military panel of one specification of abusive sexual contact.

Sentence: Forfeit \$400 per month for 12 months, restriction for 60 days, hard labor without confinement for 90 days.

Bremerton, WA Mar. 1

Name: EMN2 Michael S. Lee Kim

Conviction: By a military judge, pursuant to his pleas, of one specification each of attempted sexual assault of a child and attempting to coerce and entice a minor.

Sentence: Reduced to the grade of E-1, confined for 3 years, dishonorable discharge.

Yokosuka, Japan Mar. 31

Name: IT2 Jordan L. Mitchell

Conviction: By a military judge, pursuant to his pleas, of one specification of possessing and viewing child pornography.

Sentence: Reduced to the grade of E-1, confined for 40 months, dishonorable discharge.
